

SAMPLE WILL FOR PRIESTS

IN THE NAME OF GOD, AMEN:

California, do hereby make, publish and declare this to be my last will, that is to say:

FIRST: I revoke all wills and codicils that I have made previously.

SECOND: I declare that I am single and that I have no descendants, either living or dead.

THIRD: To the extent that I have not directed otherwise in writing, I specify that the time, manner and place of my funeral and interment shall be determined by, or under the direction of, the Roman Catholic Bishop of San Diego.

FOURTH: I direct my executor, as soon as possible after my death, to provide a stipend for \_\_\_\_\_ masses to be said for my intentions.

FIFTH: I further direct my executor, as soon as possible after my death, to cause to be said all masses for which I might have received stipends during my lifetime but which remain unsaid at the time of my death.

SIXTH: I may prepare, and may from time to time change or replace, a list of certain of my personal belongings and effects designating to which persons I desire particular items to go. Any such list will be in my handwriting and will be dated and signed by me. It will be with my will.

SEVENTH: I give, devise and bequeath the residue of my estate as follows:
